# 1. Definitions and Interpretation

### 1.1 定义

### 1.1 Definitions

The following words and expressions used in all documents under the Contract shall have the meanings as are assigned to them except where the context otherwise requires:

- 1.1.1 "工程"是指按照本合同约定实施监理与相关服务的建设工程。
- 1.1.1 "Project" means the construction project named in the Contract for which the Supervision and Related Services are to be provided.
- 1.1.2 "委托人"是指本合同中委托监理与相关服务的一方,及其合法的继承人或受让人。
- 1.1.2 "Client" means the party in the Contract, who employs the Supervisor for the Supervision and Related Services, and legal successors or assignees in title to this person.
- 1.1.3 "监理人"是指本合同中提供监理与相关服务的一方,及其合法的继承人。
- 1.1.3 "Supervisor" means the party named in the Contract, who is employed to perform the Supervision and Related Services, and legal successors in title to this person.
- 1.1.4 "承包人"是指在工程范围内与委托人签订勘察、设计、施工等有关合同的当事人,及其合法的继承人。
- 1.1.4 "Contractor" means the party entering into the contracts in relation to surveying, design, construction, etc. with the Client within the scope of the Project, and legal successors in title to this person.
- 1.1.5 "监理"是指监理人受委托人的委托,依照法律法规、工程建设标准、勘察设计文件及合同,在施工阶段对建设工程质量、进度、造价进行控制,对合同、信息进行管理,对工程建设相关方的关系进行协调,并履行建设工程安全生产管理法定职责的服务活动。
- 1.1.5 "Supervision" means the service activities conducted by the Supervisor, who is employed by the Client, to control the quality, process, cost of the construction project, manage the

Contract and information, coordinate the relationships of the parties concerned, fulfill legal duties of safety production management for the construction project, in accordance with the laws and regulations, engineering construction standards, investigation and design documents and the Contract.

- 1.1.6 "相关服务"是指监理人受委托人的委托,按照本合同约定,在勘察、设计、保修等阶段提供的服务活动。
- 1.1.6 "Related Services" means the activities conducted by the Supervisor, who is employed by the Client, to provide services at the stages of investigation, design and warranty in accordance with the contract.
- 1.1.7 "正常工作"指本合同订立时通用条件和专用条件中约定的监理人的工作。
- 1.1.7 "Regular Work" means work to be performed by the Supervisor prescribed in the General Conditions and the Particular Conditions at the time of the conclusion of the Contract.
- 1.1.8 "附加工作"是指本合同约定的正常工作以外监理人的工作。
- 1.1.8 "Additional Work" means the work to be performed by the Supervisor that is prescribed in the Contract but outside the scope of Regular Work.
- 1.1.9 "项目监理机构"是指监理人派驻工程负责履行本合同的组织机构。
- 1.1.9 "Project Supervision Organization" means the organization sent to the Project by the Supervisor to perform the Contract.
- 1.1.10 "总监理工程师"是指由监理人的法定代表人书面授权,全面负责履行本合同、主持项目监理机构工作的注册监理工程师。
- 1.1.10 "General Supervising Engineer" means the certified supervising engineer with written authorization of the Supervisor's legal representative, being fully responsible for performing the Contract and in charge of the project supervision organization.
- 1.1.11 "酬金"是指监理人履行本合同义务,委托人按照本合同约定给付监理人的金额。
- 1.1.11 "Contract Amount" means the amount paid by the Client in accordance with the Contract to the Supervisor for performing the duties under the Contract.
- 1.1.12 "正常工作酬金"是指监理人完成正常工作,委托人应给付监理人并在协议书中载明的签约酬金额。
- 1.1.12 "Payment for Regular Work" means the amount of contract amount prescribed in the Agreement, which shall be paid by the Client to the Supervisor for completion of regular work by the Supervisor.

- 1.1.13 "附加工作酬金"是指监理人完成附加工作,委托人应给付监理人的金额。
- 1.1.13 "Payment for Additional Work" means the amount paid by the Client to the Supervisor for completion of additional work by the Supervisor.
- 1.1.14 "一方"是指委托人或监理人;"双方"是指委托人和监理人;"第三方"是指除委托人和监理人以外的有关方。
- 1.1.14 "Party" means the Client or the Supervisor; "Parties" means the Client and the Supervisor; "Third Party" means any other parties concerned except the Client and the Supervisor.

- 1.1.18 "Force Majeure" means natural disasters and social emergencies that can neither be foreseen at the signing of the Contract, nor avoided or overcome in the process of the construction by the Client and the Supervisor, such as earthquake, tsunami, plague, flood, commotion, riot, war and other situations prescribed in the Particular Conditions.

The Supervisor shall perform its duties in line with the Code of Professional Ethics and Code of Conduct, in strict accordance with the laws and regulations, relevant criteria for Construction and provisions of this Contract.

- 2.4.1 在监理与相关服务范围内,委托人和承包人提出的意见和要求,监理人应及时提出处置意见。当委托人与承包人之间发生合同争议时,监理人应协助委托人、承包人协商解决。
- 2.4.1 The Supervisor shall give its comments in time with regard to the advice and requirements within the scope of supervision and relevant services from the Client and the Contractor. The Supervisor shall assist the Client and the Contractor through negotiation to settle the disputes arise between the Client and the Contractor.
- 2.4.2 当委托人与承包人之间的合同争议提交仲裁机构仲裁或人民法院审理时,监理人应提供必要的证明资料。
- 2.4.2 In the event that the disputes between the Client and the Contractor are submitted to the Arbitration Institution or the People's Court, the Supervisor shall provide necessary supporting documents.
- 2.4.3 监理人应在专用条件约定的授权范围内,处理委托人与承包人所签订合同的变更事宜。如果变更超过授权范围,应以书面形式报委托人批准。
- 2.4.3 The Supervisor shall handle the changes in the Contract agreed by the Client and the Contractor within the scope authorized by the Particular Conditions. The Supervisor shall report in writing to the Client any changes beyond the scope of authorization.

In case the instructions given by the Supervisor in order to protect the assets and personal safety in an emergency fail to be submitted to and approved by the Client beforehand, they shall be submitted in writing to the Client within 24 hours after they have been given.

- 2.4.4 Unless otherwise agreed in the Particular Conditions, the Supervisor shall be entitled to require the Contractor to replace the incompetent personnel of the Contractor.

监理人应按专用条件约定的种类、时间和份数向委托人提交监理与相关服务的报告。

The Supervisor shall submit the report to the Client concerning the Supervision and Related Services by the type, time and number of copies as stipulated in the Particular Conditions.

# 2.6 Documentation

在本合同履行期内,监理人应在现场保留工作所用的图纸、报告及记录监理工作的相关 文件。工程竣工后,应当按照档案管理规定将监理有关文件归档。

The Supervisor shall maintain at the site the drawings, reports and relevant supervision records during the Contract performance period. The Supervisor shall file the relevant supervision documents in line with the archives management regulations after the completion of Construction.

# 2.7 使用委托人的财产

# 2.7 Use of Client's assets

监理人无偿使用附录 B 中由委托人派遣的人员和提供的房屋、资料、设备。除专用条件 另有约定外,委托人提供的房屋、设备属于委托人的财产,监理人应妥善使用和保管, 在本合同终止时将这些房屋、设备的清单提交委托人,并按专用条件约定的时间和方式 移交。

he Supervisor may use the personnel, facilities, materials and equipment provided by the Client as specified in Appendix B for free. Unless otherwise agreed in the Particular Conditions, the Supervisor shall properly use and keep the Client's assets such as facilities and equipment, a list of which shall be submitted to the Client when the Construction is completed, and the Supervisor shall hand over such assets in line with the time and manner specified in the Particular Conditions.

The Client shall identify the Supervisor, the General Supervising Engineer, and the rights authorized to the Project Supervision Organization in the Contract entered into by the Client and the Contractor. The Client shall notify the Contractor if there are any changes.

委托人应按照附录 B 约定,无偿向监理人提供工程有关的资料。在本合同履行过程中, 委托人应及时向监理人提供最新的与工程有关的资料。

The Client shall provide relevant data to the Supervisor for free according to Appendix B. The Client shall provide the latest data relevant to the Construction to the Supervisor during the Contract term.

- 3.3 提供工作条件、生活条件
- 3.3 Provision of working and living conditions委托人应为监理人完成监理与相关服务提供必要的条件。

The Client shall provide necessary conditions for the completion of the Supervision and Related Services by the Supervisor.

- 3.3.1 委托人应按照附录 B 约定,派遣相应的人员,提供办公用房屋、设备,供监理人 无偿使用,另外监理人住宿、餐饮、交通等一切生活条件自理。
- 3.3.1 The Client shall provide Supervisor with appropriate personnel, office and equipment in conformity w

ith the provisions of Appendix B. In addition, the Supervisor shall be responsible for meeting his own living conditions, such as living, catering and traffic.

- 3.3.2 委托人应负责协调工程建设中所有外部关系,为监理人履行本合同提供必要的外部条件。
- 3.3.2 The Client shall be responsible for the coordination of external affairs to provide necessary external conditions for the Supervisor to perform the Contract.
- 3.4 委托人代表
- 3.4 Client representative

委托人应授权一名熟悉工程情况的代表,负责与监理人联系。委托人应在双方签订本合同后7天内,将委托人代表的姓名和职责书面告知监理人。当委托人更换委托人代表时,应提前7天通知监理人。

The Client shall authorize a representative familiar with the Project to contact with the Supervisor. The Client shall notify to the Supervisor with a written report on the name and duties of the representative within seven days after the conclusion of the Contract. The Client shall inform the Supervisor seven days in advance of any change of the representative.

# 3.5 委托人意见或要求

3.5 Opinions and requirements of the Client

在本合同约定的监理与相关服务工作范围内,委托人对承包人的任何意见或要求应通知 监理人,由监理人向承包人发出相应指令。

Within the scope of the Supervision and Related Services specified in the Contract, the Client shall notify the Supervisor of any opinion and/or requirement on the Contractor, which shall be given to the Contractor by the Supervisor.

3.6 答复

3.6 Reply

委托人应在专用条件约定的时间内,对监理人以书面形式提交并要求作出决定的事宜,给予书面答复。逾期未答复的,视为委托人认可。

The Client shall offer a written reply to the Supervisor on matters submitted in writing requiring a decision within the time specified in the Particular Conditions. Approval from the Client shall be deemed without a reply within the time limit.

3.7 支付

3.7 Payment

委托人应按本合同约定,向监理人支付酬金。

The Client shall pay the Supervisor according to the Contract.

# 4. Liability to breach of Contract

- 4.1 监理人的违约责任
- 4.1 Liability of the Supervisor for breach of the Contract 监理人未履行本合同义务的,应承担相应的责任。

The Supervisor shall be liable for breaching the Contract.

4.1.1 因监理人违反本合同约定给委托人造成损失的,监理人应当赔偿委托人损失。赔

偿金额的确定方法在专用条件中约定。监理人承担部分赔偿责任的,其承担赔偿金额由 双方协商确定。

- 4.1.1 Losses of the Client due to breaching of the Contract by the Supervisor shall be compensated for. Compensation amount shall be specified in the Particular Conditions. Compensation amount of partial liability on the Supervisor shall be determined through negotiation between the two parties.
- 4.1.2 监理人向委托人的索赔不成立时,监理人应赔偿委托人由此发生的费用。
- 4.1.2 Claim for compensation from the Supervisor denied by the Client, the Supervisor shall compensate for the losses of the Client thereby incurred.
- 4.2 委托人的违约责任
- 4.2 Liability of the Client for breach of the Contract

委托人未履行本合同义务的,应承担相应的责任。

The Client shall be liable for breaching the Contract.

- 4.2.1 委托人违反本合同约定造成监理人损失的,委托人应予以赔偿。
- 4.2.1 Losses of the Supervisor due to breaching of the Contract by the Client shall be compensated for.
- 4.2.2 委托人向监理人的索赔不成立时,应赔偿监理人由此引起的费用。
- 4.2.2 For claim for compensation from the Client denied by the Supervisor, the Client shall compensate for the losses of the Supervisor thereby incurred.
- 4.2.3 委托人未按合同规定日期付款的,逾期半个月,监理人有权暂停服务。
- 4.2.3 Suspension of services if the Client fails to make payment before the deadline specified in the Contract, which is half a month overdue.
- 4.3 除外责任
- 4.3 Exclusions

因非监理人的原因,且监理人无过错,发生工程质量事故、安全事故、工期延误等造成 的损失,监理人不承担赔偿责任。

The Supervisor shall not be liable for any loss due to quality accidents, safety accidents and project delay caused by a party other than the Supervisor who is proved free of fault in so far as the loss is concerned.

Each Party shall bear their own losses caused by force majeure resulting in total or partial non-

performance of the Contract.

- 5.1 支付货币
- 5.1 Currency for payment

除专用条件另有约定外,酬金均以人民币支付。涉及外币支付的,所采用的货币种类、比例和汇率在专用条件中约定。

The payments shall be made in the currency of RMB unless otherwise specified in the Particular Conditions. The currency, proportion and exchange rate shall be agreed on in the Particular Conditions if any payment via a foreign currency is involved.

- 5.2 Payment application

监理人应在本合同约定的每次应付款时间的 3 天前,向委托人提交支付申请书。支付申请书应当说明当期应付款总额,并列出当期应支付的款项及其金额。

The Supervisor shall submit to the Client a payment application three days before the due time specified in the Contract. The payment application shall define the total amount of payables and list each payable item and each amount.

The contract amount shall include the payment for Regular Work, payment for Additional Work, rewards for proposals on improvement and costs.

委托人对监理人提交的支付申请书有异议时,应当在收到监理人提交的支付申请书后7天内,以书面形式向监理人发出异议通知。无异议部分的款项应按期支付,有异议部分的款项按第7条约定办理。

Holding different opinions on a payment application submitted by the Supervisor, the Client shall notify the Supervisor in a written form within seven days upon receiving the application. Undisputed payables shall be paid in due time, while disputed payables shall be handled in line with Article 7.

# 6. Validity, Change, Suspension, Cancellation and Termination of Contract

6.1 生效

# 6.1 Validity

Unless otherwise regulated by laws or specified in the Particular Conditions, the Contract shall be effective as of the date the legal representatives of the Client and the Supervisor or their authorized representatives sign and stamp a seal on the Agreement.

6.2变更

### 6.2 Change

- 6.2.1 任何一方提出变更请求时,双方经协商一致后可进行变更。
- 6.2.1 Changes may be made based on the agreement after consultation between the two Parties if either Party proposes a change request.
- 6. 2. 2 除不可抗力外,因非监理人原因导致监理人履行合同期限延长、内容增加时,监理人应当将此情况与可能产生的影响及时通知委托人。增加的监理工作时间、工作内容应视为附加工作。附加工作酬金的确定方法在专用条件中约定。
- 6.2.2 Except for force majeure, the Supervisor shall inform the Client of any extension of the Contract term and/or addition to the Contract not caused by the Supervisor and any possible impact(s) within a reasonable time limit. Any additional time and work thereby resulted shall be deemed as Additional Work. Payment for this part of Additional Work shall be specified in the Particular Conditions.
- 6. 2. 3 合同生效后,如果实际情况发生变化使得监理人不能完成全部或部分工作时,监理人应立即通知委托人。除不可抗力外,其善后工作以及恢复服务的准备工作应为附加工作,附加工作酬金的确定方法在专用条件中约定。监理人用于恢复服务的准备时间不应超过 10 天。
- 6.2.3 The Supervisor shall notify the Client immediately if the Supervisor is unable to perform the Contract in part or in whole due to any circumstance change after the Contract comes into effect. Except for force majeure, the remedies and preparations for resumption shall be deemed as Additional Work, the payment of which shall be specified in the Particular Conditions. The Supervisor's preparation for service resumption may not exceed 10 days.
- 6.2.4 合同签订后, 遇有与工程相关的法律法规、标准颁布或修订的, 双方应遵照执行。

由此引起监理与相关服务的范围、时间、酬金变化的,双方应通过协商进行相应调整。 6.2.4 After the Contract is signed, the two Parties shall abide by any new laws, regulations, standards and any revision of existing ones relevant to the Project. Adjustments shall be made through consultation between the two Parties where changes to the scope, period and contract amount of the Supervision and Related Services are thereby caused.

- 6.2.5 因非监理人原因造成工程概算投资额或建筑安装工程费增加时,正常工作酬金应作相应调整。调整方法在专用条件中约定。
- 6.2.5 If the construction investment budget or the construction and installation cost is increased and the Supervisor is not responsible for the increase, the payment for Regular Work shall be adjusted correspondingly. The adjustment method is specified in the Particular Conditions.
- 6.2.6 因工程规模、监理范围的变化导致监理人的正常工作量减少时,正常工作酬金应作相应调整。调整方法在专用条件中约定。
- 6.2.6 If the amount of Regular Work is reduced due to changes in the construction scale and the scope of Supervision, the payment for Regular Work shall be adjusted correspondingly. The adjustment method is specified in the Particular Conditions.

### 6.3 暂停与解除

# 6.3 Suspension and cancellation

除双方协商一致可以解除本合同外,当一方无正当理由未履行本合同约定的义务时,另 一方可以根据本合同约定暂停履行本合同直至解除本合同。

In addition that the Contract may be canceled with the consent of the two Parties through negotiation, either Party may suspend the Contract or even cancel it if the other Party fails to perform the obligations under the Contract without justifiable reasons.

- 6.3.1 During the term of this Contract, the two Parties may cancel the Contract or part of the obligations of the Supervisor with the consent of both Parties through negotiation if the whole or a part of the Contract cannot be performed or the performance thereof does no longer have any significance due to factors unforeseeable or uncontrollable by both Parties. Before cancellation, the Supervisor shall make appropriate arrangements to minimize the expenditure. 因解除本合同或解除监理人的部分义务导致监理人遭受的损失,除依法可以免除责任的情况外,应由委托人予以补偿,补偿金额由双方协商确定。

Except where the liabilities can be exempted by law, the Client shall compensate for the losses of the Supervisor caused by the cancellation of the Contract or the part of the Supervisor's obligations, and the amount of compensation shall be determined through negotiation between the two Parties.

解除本合同的协议必须采取书面形式,协议未达成之前,本合同仍然有效。

An agreement shall be made for the cancellation in writing, and the Contract remains valid before the conclusion of the agreement.

- 6.3.2 在本合同有效期内,因非监理人的原因导致工程施工全部或部分暂停,委托人可通知监理人要求暂停全部或部分工作。监理人应立即安排停止工作,并将开支减至最小。除不可抗力外,由此导致监理人遭受的损失应由委托人予以补偿。
- 6.3.2 During the term of the Contract, the Client may notify the Supervisor to suspend the whole or a part of the work if the suspension is not caused by the Supervisor. The Supervisor shall arrange for the suspension of work and minimize the expenditure. Except for force majeure, the Client shall compensate for the Supervisor's losses thereby caused.

暂停部分监理与相关服务时间超过 30 天,监理人可发出解除本合同约定的该部分义务的通知;暂停全部工作时间超过 30 天,因不可抗力或政府原因导致临时停工的情况除外,监理人可发出解除本合同的通知,本合同自通知到达委托人时解除。委托人应将监理与相关服务的酬金支付至本合同解除日,且应承担第 4.2 款约定的责任。

The Supervisor may notify the Client to cancel the obligations in the part of the Contract if the suspension of the Supervision and Related Services thereof exceeds 30 days; Except for the force majeure or the temporary suspension caused by government, the Supervisor may notify the Client to cancel the Contract if the suspension of the whole work exceeds 30 days, and the Contract is canceled upon the arrival of the Cancellation Notice at the Client. The Client shall pay for the Supervision and Related Services accrued till the cancellation date of the Contract, and shall perform the obligations specified in Section 4.2.

6.3.3 当监理人无正当理由未履行本合同约定的义务时,委托人应通知监理人限期改正。若委托人在监理人接到通知后的 7 天内未收到监理人书面形式的合理解释,则可在 7 天内发出解除本合同的通知,自通知到达监理人时本合同解除。委托人应将监理与相关服务的酬金支付至限期改正通知到达监理人之日,但监理人应承担第 4.1 款约定的责任。6.3.3 When the Supervisor does not perform the obligations in the Contact without any justifiable reason, the Client shall inform the Supervisor to make corrections within a prescribed period. Without any reasonable explanation in writing from the Supervisor within 7 days after

the Supervisor receives the notice, the Client may send the notice of cancellation within 7 days, and the Contract is canceled upon arrival of the notice at the Supervisor. The Client shall pay for the Supervision and Related Services accrued till the day when the correction notice arrives at the Supervisor, but the Supervisor shall perform the obligations specified in Section 4.1.

- 6.3.4 监理人在专用条件 5.2 中约定的支付之日起 14 天后仍未收到委托人按本合同约定应付的款项,可向委托人发出催付通知。委托人接到通知 7 天后仍未支付或未提出监理人可以接受的延期支付安排,监理人可向委托人发出暂停工作的通知并可自行暂停全部或部分工作。暂停工作后 7 天内监理人仍未获得委托人应付酬金或委托人的合理答复,监理人可向委托人发出解除本合同的通知,自通知到达委托人时本合同解除。委托人应承担第 4.2.1 款约定的责任。
- 6.3.4 If the Supervisor has not received the payable amount prescribed in the Contract from the Client within 14 days from the date of payment specified in the Particular Conditions 5.2, a payment reminder can be sent to the Client. If the Client does not pay or put forward an acceptable payment-delay arrangement 7 days upon receiving the notice, the Supervisor may send a notice of suspension and immediately suspend performing a part or all of the Services. If the Supervisor still has not received the payable amount or a reasonable reply from the Client within 7 days after the suspension of work, the Supervisor may send a cancellation notice to the Client, and the Contract is canceled upon arrival of the notice to the Client. The Client shall bear the responsibilities as prescribed in Section 4.2.1.
- 6.3.5 因不可抗力致使本合同部分或全部不能履行时,一方应立即通知另一方,可暂停或解除本合同。
- 6.3.5 If a part or all of the obligations under the Contract cannot be performed due to force majeure, one Party shall notify the other immediately to suspend or terminate the Contract.
- 6.3.6 本合同解除后,本合同约定的有关结算、清理、争议解决方式的条件仍然有效。
- 6.3.6 The provisions concerning settlement, winding-up, and settlement of disputes under the Contract remain effective after the cancellation of the Contract.
- 6.4 终止
- 6.4 Termination

以下条件全部满足时,本合同即告终止:

The Contract terminates when all of the following conditions are met:

Where the parties fail to resolve any dispute hereunder within 14 days or other period agreed by the two Parties, the dispute shall be submitted to the mediator prescribed in the Particular Conditions or agreed on by the two parties afterwards.

### 7.3 仲裁或诉讼

### 7.3. Arbitration or lawsuit

双方均有权不经调解直接向专用条件约定的仲裁机构申请仲裁或向有管辖权的人民法院提起诉讼。

Both Parties are entitled to directly apply to the arbitration institution prescribed in the Particular Conditions for arbitration without meditation, or bring a lawsuit with the People's Court of competent jurisdiction.

### 8. 其他

# 8.1 外出考察费用

### 8.1 Off-site inspections

With the approval of the Client, off-site inspections may be compensated for by the Client after review.

委托人要求监理人进行的材料和设备检测所发生的费用,由委托人支付,支付时间在专

用条件中约定。

Any test conducted by the Supervisor on materials and equipment as required by the Client shall be compensated by the Client on the terms prescribed in the Particular Conditions.

### 8.3 咨询费用

### 8.3 Consultation

经委托人同意,根据工程需要由监理人组织的相关咨询论证会以及聘请相关专家等发生的费用由委托人支付,支付时间在专用条件中约定。

With the approval of the Client, relevant consultation and verification meetings organized by the Supervisor as required by the Project as well as the invitation of relevant experts shall be compensated by the Client on the terms prescribed in the Particular Conditions.

### 8.4 奖励

### 8.4 Reward

监理人在服务过程中提出的合理化建议,使委托人获得经济效益的,双方在专用条件中约定奖励金额的确定方法。奖励金额在合理化建议被采纳后,与最近一期的正常工作酬金同期支付。

Where the Client gains economic benefits from the reasonable advice put forward by the Supervisor during the service process, the Parties shall prescribe the determination method of reward amount in the Particular Conditions. The reward shall be paid at the same period of payment as the latest Regular Work after the adoption of the reasonable advice.

### 8.5 守法诚信

### 8.5 Law-abiding and integrity

监理人及其工作人员不得从与实施工程有关的第三方处获得任何经济利益。

The Supervisor and its staff shall not gain any economic benefits from a third party related to the construction Project.

#### 8.6 保密

#### 8.6 Confidentiality

双方不得泄露对方申明的保密资料,亦不得泄露与实施工程有关的第三方所提供的保密资料,保密事项在专用条件中约定。

Either Party shall not disclose the confidential information specified by the other Party or provided by a third party concerning the Project, and the confidential information is prescribed in the Particular Conditions.

### 8.7 通知

### 8.7 Notification

本合同涉及的通知均应当采用书面形式,并在送达对方时生效,收件人应书面签收。

The notices herein shall all be made in writing, and take effect upon arrival at the other Party. The recipient shall sign upon receiving the notices.

### 8.8 著作权

### 8.8 Copyright

监理人对其编制的文件拥有著作权。

The Supervisor is entitled to the copyright of the documents prepared by himself.

监理人可单独或与他人联合出版有关监理与相关服务的资料。除专用条件另有约定外,如果监理人在本合同履行期间及本合同终止后两年内出版涉及本工程的有关监理与相关服务的资料,应当征得委托人的同意。

The Supervisor may, solely or jointly with others, publish information concerning the Supervision and Related Services. Unless otherwise provided in the Particular Conditions, the Supervisor may not publish information concerning the Supervision and Related Services related to the project during the Contract term and within 2 years after the termination of the contract without the approval from the Client.
